School Attendance & Late Arrival

A reminder that school begins at **8:45am** each morning and I would ask everyone to please arrive in school between 8:30am-8:45am. Late arrival can have an impact on the classroom routine and the children often miss important teaching and learning. Regular late arrivals and pupil attendance is monitored by the EA Education Welfare Officer. If for any reason your child will be late or absent, please contact the school office or use the 'Report Absence' on the school website.

Please note that for safeguarding reasons the back gate leading to the P1 and P2 playground and the door at the new entrance for P1/P2/P4/P6 will be locked after 8:45am each morning. The children will be unable to access their classrooms via this route. If your child is late, you should ring the buzzer at the front reception door and a member of staff will accompany your child to the classroom.

For Safeguarding reasons, the front door reception area is supervised by Mr McElroy and Gemma each morning and the P1/P2/P4/P6 entrance door is supervised by Siobhan our caretaker. The pupils are supervised by the teachers in the classrooms from 8:30am.

Parents are not permitted into the school building without permission from the Principal. Please contact the school office if you need to enter the school building for any reason.

Home Collection and Car Park Area

At the end of the school day, all pupils are taken safely to their home collection points and when parents/carers are identified by the teacher, they are handed over to their authorised adults. Adults should park safely in the school playground and leave their vehicles to collect their child/children.

Adults should avoid parking at the small entrance gate at the front of the school as this area is to be kept clear for the safe use of the footpath and to cross the road safely.

It is extremely important that adults please follow these health and safety measures to safeguard our pupils and entire school community.

Early Collection of Pupils

For security, attendance records and insurance purposes, the school have guidelines in place for early collection of pupils. No child will be released early from class unless the parent/carer or named designated person calls personally to the school office and fills in the necessary details.

The class teacher will then be informed, and the child will be collected from the office by the parent, guardian or designated person.

ParentPay-Cashless System

We have recently explored the possibility of introducing ParentPay which is a secure online payment system that replaces cash payments for school meals, trips, events, activities, and other school expenses. It means children don't have to bring cash with them to school.

ParentPay is easy to use, secure and protects all personal details. You can top up your account when you want, so you can budget money for lunches, trips, and activities. You can top up online or with cash at your local PayPoint.

ParentPay offers you the freedom to make payments whenever and wherever you like, 24 hours a day, 7 days a week. You can be safe in the knowledge that the technology used is of the highest internet security available.

If you have more than one child at a school or have children at different schools that use the ParentPay system, you can add them into one single account and have one login for all your children. Making a payment is straightforward and ParentPay holds a payment history for you to view at a later date; no card details are stored in any part of the system.

We aim to introduce the payment system this term. You will receive a letter with your activation details and instructions on how to set up your ParentPay account. You will have a secure online account, activated using a unique username and password. You will be prompted to change these and to keep them safe and secure.

Many schools are now using the Parent Pay App and we are looking forward to using the system which has so many benefits for everyone.
